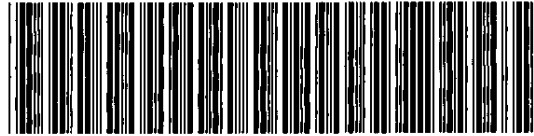

ARTICLES OF AMENDMENT

THE ARTICLES OF INCORPORATION

OF

ONEHOPE COALITION OF TRANSFORMATIONAL CHURCHES, INC.

Pursuant to a merger of OneHope, Inc. (Document No. N42197) into OneHope Coalition of Transformational Churches, Inc. (Document No. N09000010658) (the "Surviving Corporation") and in accordance with the provisions of F.S. 617.1001, the Surviving Corporation adopts the following articles of amendment to its articles of incorporation:

- 1. Article One of the articles of incorporation shall be amended in its entirety to read as follows:

ARTICLE ONE


NAME

The name of this corporation shall be **OneHope, Inc.**

- 1. This amendment does not require the vote of the members of the Surviving Corporation.
- 2. The amendment was approved by the board of directors of the Surviving Corporation on the 1st day of March, 2017, and the number of votes was sufficient for approval.
- 3. The effective date of this amendment shall be April 1, 2017.


