Article III Purpose

The purposes for which this corporation is organized are for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. Article IV Manner of Election

No Director shall have any right, title, or interest in or to any property of the corporation.
