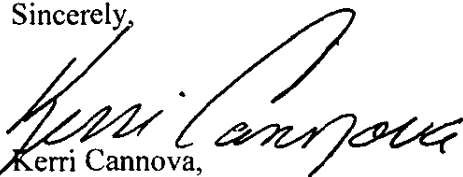

*ARTICLE I. NAME*

#### *ARTICLE VII. AMENDMENTS*

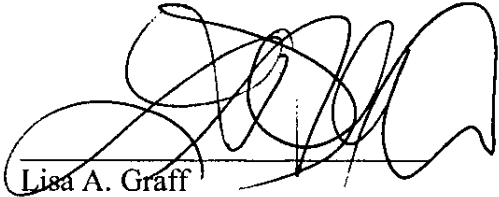

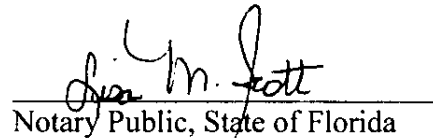

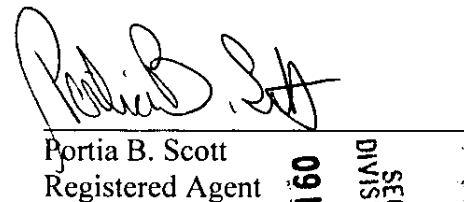
