Articles of Incorporation of

International Initiative for Mental Health Leadership, Inc.

The undersigned citizen of the United States desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, doesn't hereby certify:

First: The name of the Corporation shall be International Initiative for Mental Health Leadership, Inc.

Second: The place in this state where the initial principal office and mailing address of the Corporation is to be located is 1876-A Eider Court, Tallahassee, Leon County, Florida 32308.

Third: Said corporation is organized pursuant to chapter 617 Florida Statutes exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The names and addresses of the persons who are the initial directors of the corporation are as follows:

- 1. Donald Hevey, chairman of the board and director: 1876-A Eider Court, Tallahassee, FL 32308.
- 2. Ken Jue, 23 Ridgewood Avenue, Keene, N.H. 03431, director
- 3. Dennis Morrison, 365 South Park Ridge Road, Suite 103, Bloomington, IN 47401, director

Directors shall be elected as provided in the Corporation's by-laws. The Corporation shall have no members.

Fifth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by

a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Seventh: These articles may be amended by 2/3 vote of the directors so long as such amendments are consistent with all requirements of the law relating to not for profit corporations.

Eighth: The name and Florida street address of the registered agent is Donald Hevey, 1876-A Eider Court, Tallahassee, FL 32308.

Ninth: The name and address of the Incorporator is Donald Hevey, 1876-A Eider Court, Tallahassee, Fl 32308.
