ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE ZEBRA FOUNDATION FOR YOUTH, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, THE ZEBRA FOUNDATION FOR YOUTH, INC., a Florida Not For Profit Corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:
