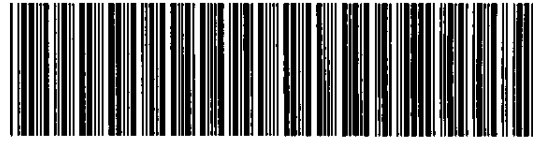



Article 111 is amended to read:

**Outreach Program** – The corporation is organized exclusively for charitable, spiritual, educational and scientific purposes, making distributions to organizations that qualify as an exempt organization under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, providing Community resources for Sarasota and Charlotte County residents. Domestically provide services and necessities such as food, clothing, shelter, education, multi-lingual services, family and individual counseling, vocational counseling and job assistance, end of life services, spiritual direction and protection for the homeless and incarcerated. In addition we will work and partner with agencies and similar charities as possible for common goals.

**Cities of Refuge: Addicted Treatment/Residences** – Scientific research of addiction issues in the region, provide prevention education and Intensive Treatment. Provide a Residential facility for those addicted and suffering emotional disturbances. Educate the community regarding addiction and to facilitate effective treatment to individuals. Housing for the homeless, those released from incarceration, veterans and their families will be available through the program. Face-of-Hope Foundation Inc. will foster and encourage positive entrepreneurial thinking and collaboration. Additionally, our program will research and assist those with terminal illnesses.

**International program** – Face\_of\_Hope Foundation Inc. is organized to provide humanitarian aid to Ghanaians in West Africa as well as other countries on the African continent, accomplished by kindred individuals and organizations. Establishing an International Foster Home complex Africa. Face\_of\_Hope Foundation Inc. will provide useful shipments of food, clothing, household and educational supplies. Scientific research will be conducted reviewing natural resources for use in medical or personal products. Provisions for farming and for the international import and exportation of products of domestic necessity.
