Article 111 is amended to read:

Outreach Program – The corporation is organized exclusively for charitable, spiritual, educational and scientific purposes, making distributions to organizations that qualify as an exempt organization under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, providing Community resources for Sarasota and Charlotte County residents.
