Articles of incorporation

In compliance with chapter 617, F.S., (Not for Profit)

ARTICLE I - NAME

The name of this corporation shall be:

Helping Hands Faith Ministries, Inc

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and the mailing address of

this corporation shall be: **25 East Blue Heron BLVD**

Riviera Beach FL. 33404 and it may have such other places of business, both within and without the State of Florida and in foreign countries, as might be necessary or convenient.

ARTICLE III - PURPOSES

The specific purposes for which the corporation is organized are:

To help needy families and unemployed persons here in Florida;
to provide them with food, clothing, shelter and emergency cash assistance.

To assist orphans, needy families and poor people in Haiti in the areas of
agriculture, health, nutrition and education

so they can improve their life conditions.

ARTICLE IV- MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be stated in the Bylaws of the corporation.

ARTICLE V -LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in the
Section 617.0302, Florida Statutes.

ARTICLE VI - DEDUCTION OF ASSETS

No part of the net income or assets of the corporation shall insure to the benefits of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the corporation in carrying out one or more of its purposes.

ARTICLE VII - PROHIBITION AGAINST POLITICAL ACTIVITIES

No substantial part of activities of the corporation shall be devoted to the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) of any political campaign on behalf of any candidate for public office.

ARTICLE VIII – DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all assets of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501 (C) 3 of the Internal Revenue code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the board of directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court in and for Palm Beach County, Florida, exclusively for such purposes or to such organization or organizations, as such Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX -AMENDMENTS

Amendments to the articles of Incorporation may be prepared by any member, but requires a majority vote of the board of directors for passage and adoption.

ARTICLE X - BOARD OF DIRECTORS

The business of this corporation shall be conducted by a Board of Directors not less than three (3) Directors, the exact number of Directors to be fixed by the by-laws of this corporation. The Board of Directors shall have the powers to make, alter, or rescind the corporation by-laws. The Board of Directors are all elected by a majority vote of the membership.

ARTICLE XI - OFFICES

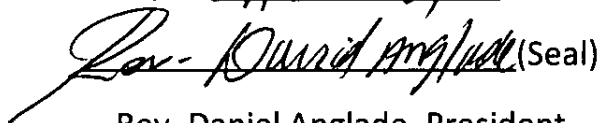

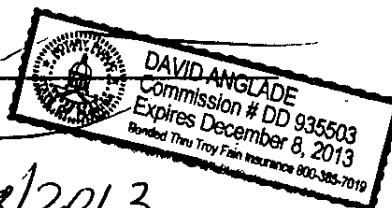
