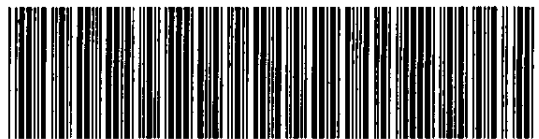

**ARTICLES OF INCORPORATION  
OF**

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I NAME**

The name of the corporation shall be: START OFF SMART, INC.

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**

The specific purpose(s) for which the corporation is organized is (are) for charitable purposes within the meaning of section 501C 3 of the Internal Revenue Service Code: To provide resources and support services in order to provide relief of the poor, the distressed or the underprivileged and those who have experienced violence within their home, in order to improve their quality of life through independence and safety..

To enhance family management techniques that will preserve and protect the family unit by providing resources for psychological services, re-location from an abuser, family safety plans and family oriented case planning services. To reduce the root cause of dysfunctional behaviors, in order to reduce family violence, neighborhood crime and the duplication of services, thus resulting in a reduction of repeat victimization.

To provide the community of Homestead with services that provide a continuum of care, which addresses local social issues, health care, childcare, education, counseling and public safety collectively, in order to improve the quality of life for families.

No part of the net bearing of the corporation shall inure to the benefit of, or be distributed to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services

rendered and to make payments and distributions in furtherance of the purposes listed above. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for office.

#### **ARTICLE IV MANNER OF ELECTION**

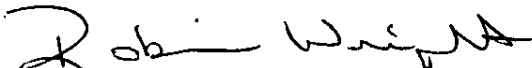
