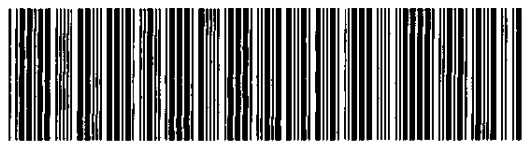

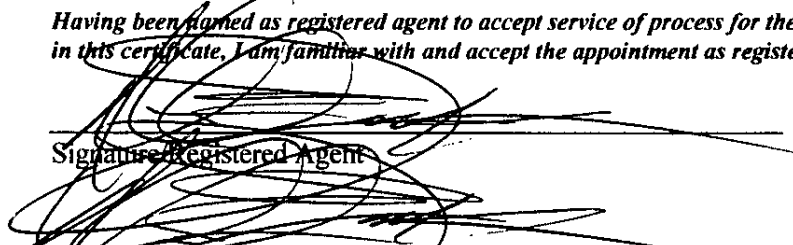

ARTICLES OF INCORPORATION
OF
ARK RESTORATION CHRISTIAN CHURCH

Article III PURPOSE

Said not-for-profit corporation is organized exclusively for religious purposes within the meaning of the section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code. No part of the corporation's net earnings shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purpose set forth in its Statement of Purpose. The corporation's property is irrevocably dedicated to religious purposes and no part of the corporation's net income or assets shall ever inure to the benefit of any director, officer, private individual, or member thereof. The corporation shall not engage in prohibited political and legislative activities or any activity which is not allowed pursuant to Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of this corporation. Upon dissolution of the corporation, none of the assets shall be given to the benefit of any member, private individual or business entity. Assets shall be distributed to a charitable organization, as designated by the Board of Trustees, within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code .
