**Articles of Incorporation for  
The South Howard Community Outreach Corporation**

The undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation laws of The State of Florida as set forth in Chapter 617, Florida Statutes, do hereby certify:

**Article I - Name**

The name of the Corporation shall be The South Howard Community Outreach Corporation.

**Article II – Principal Office**

The principal place of business and mailing address for The South Howard Community Outreach Corporation shall be

**Article III - Purpose**

The South Howard Community Outreach Corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions and donations to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Said organization shall seek to aid in the preservation and betterment of the greater Tampa Bay area community by committing its efforts to fundraising in support of charitable causes including, but not limited to; combating community deterioration; relief of the poor; the erection or maintenance of public buildings, monuments, or works; public safety; advancement of education and science; combating disease; prevention of cruelty to children and animals; defending human rights secured by law; and lessening the burdens to government.

**Article IV – Manner of Election**

The Managing Director shall appoint the members of the board of directors who will serve at his discretion.

**Article VIII - Restrictions**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article ~~III~~ <sup>IX</sup> hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation



**Article IX - Dissolution**


Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
