

AMEND: ARTICLE III - THE SPECIFIC PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED IS : FORMED EXCLUSIVELY FOR CHARITABLE PURPOSES TO PROVIDE THE MOST JOB-READY DISADVANTAGE YOUTH/AT RISK STUDENTS WITH SHORT TERM PAID INTERSHIPS, JOB PLACEMENTS AND FOLLOW UP SERVICES WITHIN THE MEANING OF SECTION 501 ( C ) (3) OF THE INTERNAL REVENUE CODE OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.
