Articles Of Incorporation      Article III      Purpose

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth.

The corporation shall not participate in the use of propaganda, or otherwise attempt to influence legislation, and the corporation shall not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

Upon dissolution of the corporation, assets shall be distributed for a public purpose for one or more exempt purpose within the meaning of Section 501(c)(3) of the Internal Revenue Code.
