

ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

CHABAD OF WEST DAVIE, INC.

(Not for Profit Corporation)

Article III of the Articles of Incorporation of CHABAD OF WEST DAVIE, INC. is deleted in its entirety and replaced as follows:

Article III

The specific purpose for which this corporation is organized is to serve as a center for Jewish life and education within the community of West Davie, Florida, with the mission of teaching and instilling Jewish values and tradition in one's life and to make the beauty and light of Judaism accessible to all Jews, regardless of their background or affiliations. The organization will seek to achieve such purposes through youth programs, adult education, and community services.

The corporation is organized exclusively for charitable, religious, educational and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
