

The undersigned, acting as incorporator of REVISTA SURCO SUR INC. under the Florida Business Corporation Act, hereby adopts the following Articles of Amendment:

Pursuant to the provisions of section 617.1006, Florida Statutes, this ***Florida Not For Profit Corporation*** adopts the following amendment to its Articles of Incorporation:

**I - SCOPE OF AMENDMENT**

ARTICLE V - BOARD OF DIRECTORS AND OFFICERS of the original Articles of Incorporation shall be amended to add Gabriel Cartaya as an officer and initial board member. The amended Article V shall, from now on, read as follows:

**ARTICLE V - BOARD OF DIRECTORS AND OFFICERS**

Board Of Directors:

The manner of election and number of Directors and Officers will be provided in the Corporation's bylaws. The number, however, shall never be less than three (3)

Officers:

The Board may elect a President, Vice President, a Secretary and a Treasurer and any other officers and assistants as may be provided by the bylaws. Each officer shall be elected by majority vote of the board of directors (and may be removed by majority vote of the board of directors) at such time and manner as may be prescribed by the bylaws or by law.
