Amendments to Articles of Incorporation for the Florida Keyskeeper, Inc. No. N10000010690

Article VIII Section 3 is amended to the following:

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section 4 below is added to Article VIII:

Notwithstanding any other provision of this document, the organization shall not further any purpose not permitted (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or any corresponding section of any future federal tax code, or (b) by any organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or any corresponding section of any future federal tax code.
