**Articles of Incorporation of The Compassionate Cure Foundation, Inc.**

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**First:** The name of the Corporation shall be The Compassionate Cure Foundation, Inc.

**Second:** The place in this state where the principal office of the Corporation is to be located at 4624 Tinsley Drive in the City of Orlando, Orange County, 32839.

**Third:** Said corporation is organized exclusively charitable, religious, educational and scientific purposes specifically, for educating the public about alternative healing treatments including, but not limited to herbal medicine, the religious connection to healing, medicinal and religious benefits of cannabis, promoting scientific research on these elements, and including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Fourth:** The names and addresses of the persons who are the initial trustees of the corporation are as follows:

**Fifth:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

**Sixth:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Seventh:** The trustees shall be elected each year by nomination and majority vote of the members.

**Eighth:** The Registered Agent is Kimberly Russell 4624 Tinsley Drive Orlando, FL 32839

**Ninth:** The Incorporator is Kimberly Russell 4624 Tinsley Drive Orlando, FL 32839

**Tenth:** The corporation shall have and exercise all rights and powers that are permitted by the laws of the State of Florida for Not for Profit Corporations, including powers which may be conferred by law after the date of incorporation.

**Eleventh:** These articles may be altered, amended or repealed by a majority vote of the trustees.
