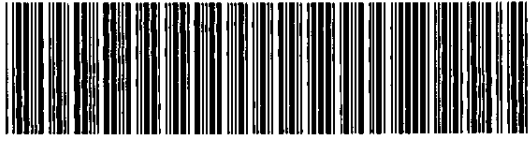





Please accept this as my letter of resignation and that I will ask that you cease and desist from using my name, the name of Honolulu University or any of the information I previously supplied, including my passport and my photo to you to continue this undertaking and venture on this corporation. Please be advised that I will no longer be responsible for the registration and expenses for AACAC website and its involvement whatsoever. Therefore please remove my name as its Vice Chairman.
