In compliance with the requirements of the Florida Statutes, Chapter 617, the undersigned serves as incorporator, for the purpose of forming a corporation not-for-profit and does hereby certify:

Article I

Name of Corporation

The name of the corporation is Chandler's Legacy, Inc. (hereafter called the "Corporation").

Article II

Principal Office

The principal office and mailing address of the Corporation shall be 1825 Blackfoot Trail, St. Cloud, Florida 34771.

Article III

Purposes and Powers

The purposes for which this corporation is organized are:

- (1) To provide educational scholarship funds for at-risk youth.
- (2) To raise awareness about teen violence and provide educational prevention methods.

This Corporation is organized exclusively for charitable, educational, religious and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
