### ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

### **BOCA JEWISH CENTER, INC.**

(Not for Profit Corporation)

Article III of the Articles of Incorporation of Boca Jewish Center, Inc. is deleted in its entirety and replaced as follows:

### Article III

This corporation is organized for the advancement of orthodox Judaism. In furtherance of such purpose, the corporation will establish and maintain a vibrant Learning Center that will provide religious instruction. The corporation's activities will include, but not necessarily be limited to, the following: lunch and learn classes, Bar and Bat Mitzvah classes, lectures, Talmud and Halacha study, prayers, and other activities which are intended to foster the learning of the principles of orthodox Judaism.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
