The undersigned, acting as Incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopts (s) the following Article of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be ASOCIACIÓN PATRIOTICA CUBANA, INC.

ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal and mailing address of this corporation is: 120 NW 64th AVENUE, Miami, Florida 33126

ARTICLE III: PURPOSE(S)

The purpose of this corporation is to provide help for the men, women and families affected by the pain and lack of freedom of our motherland, Cuba. To do this we will raise awareness of the abuse of human rights that have affected our country for more than 50 years and also attempt to help our people inside and outside of Cuba.

ARTICLE IV: MANNER OF ELECTIONS OF DIRECTORS

The manner in which the directors are elected or appointed are as follows: Under the direction of the president with the officials that form the active heads in each moment; and with elected rotation every period of 2 years. This institution shall be governed by the provisions contained in the corporation by laws adopted in the 2nd meeting of the Board of Directors 2/3 vote and approved members. This organization must be recognized as exempt from the Federal Income Taxation under Section 501(C)3 and 170(C)(2) of the Internal Revenue Service, for local government, State & Federal as a public purpose.

The corporate powers of this corporation are as provided the section 617.0302, Florida Statutes, unless limited as follows: The money and real power of this corporation may not be used for the benefits of any director, officials, or members out of our mission and goals.

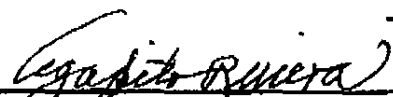
