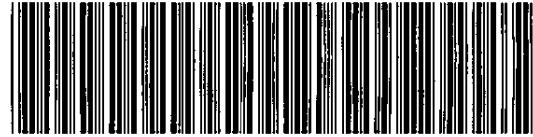

Pursuant to the provisions of the Florida Not for Profit Corporation Act (the "Act"), Living Arts Foundation, Inc. (the "Corporation") adopts the following amendment to its Articles of Incorporation:

1. The name of the Corporation is: Living Arts Foundation, Inc. The Articles of Incorporation of the Corporation were filed on August 2, 2011 and assigned Document Number: N11000007335.
2. The Articles of Incorporation of the Corporation are hereby amended by deleting Article I thereof in its entirety and substituting the following in its place:

"ARTICLE I
NAME

The name of the Corporation shall be: BENZAITEN CENTER FOR CREATIVE ARTS, INC. (the "Corporation").".
