## **Purpose**

The "Disabled Veterans Hot Rod Club" (DVHRC) is a club for disabled veterans of all wars fought by American men and women. Too many of our veterans come home with physical injuries (loss of limbs, eyes, hearing, etc.), as well as mental/psychological problems. Many of these disabled vets feel as though they have no life and isolate themselves from everyone and everything, with nothing exciting in their lives. Some of them attempt suicide, and all too many of them succeed.

Our goal is to encourage disabled veterans to join the DVHRC and work on various hot rods, using any skills they have (or we will teach them each step along the way) to complete a running, drivable street rod – something they can be proud of just knowing they completed with their own hands alongside other disabled vets. These cars will be driven to car shows and put on display for everyone to see. By building a car, it will engage the vets in something worthwhile and show them how they can enjoy a good life with their disability.


## **Bylaws:**

- 1. The membership requirements for the Disabled Veterans Hot Rod Club (DVHRC) are very straightforward. To become a member, you must:
  - a. Have served in the U.S. military, have a service-connected disability and produce proof of a rating of 10% to 100%,
  - b. OR be recommended by a Board member and voted in with a majority vote,
  - c. AND must produce a DD214 showing dates and character of service is required at time of application.
- 2. Officers of the DVHRC, Inc.
  - a. Executive Director
  - b. Assistant to the Executive Director
  - c. Secretary/Treasurer
  - d. Sgt. at Arms
  - e. Adjutant
- \* In the instance that any Officer or Board Member leaves his position (for any reason, death, resignation, etc.), that position will be filled by the Executive Board's assignment.

#### **Duties of Corporate Officers:**

- a. Executive Director: Will serve as Chief Administrative Officer of the DVHRC and will preside over all meetings. He/she shall have general supervision over the affairs of the DVHRC. He/she shall perform such other duties as directed by the general membership.
- b. Assistant to the Executive Director: Will assume the duties of the Executive Director in his/her absence. He/she will assist the Executive Director in the performance of his/her duties when called on by the Executive Director to do so.
- c. Secretary: Will keep a full and correct record of all proceedings at meetings. He/she will maintain membership records as may be required by the general membership. He/she shall be responsible for all DVHRC correspondence, agendas, meeting minutes, etc. He/she shall work in conjunction with the Treasurer (if he/she is not also the Treasurer) to provide filings and annual reports to the State and Federal agencies as required.
- d. Treasurer: Will have charge of all finances of the DVHRC. He/she will have charge of disbursing funds as directed by the Executive Board. He/she will establish a checking account requiring two signatures as determined by the Executive Director and the Treasurer. He/she will give detailed financial reports at each regular meeting. He/she will be responsible for the bookkeeping/accounting needs of the DVHRC.
- e. Sgt. at Arms: Will maintain order during DVHRC meetings. He/she will be the logistics person in charge of organized car shows and other fundraising events.
- f. Adjutant: Will assist Executive Director and Assistant to the Executive Director to ensure that all decisions agreed upon and voted upon by the Executive Board members are carried out as noted in the minutes of the meetings.


#### Meetings:

- a. Executive Board Meetings: Will be held regularly at a date, time and place as voted on by the Board members.
- b. Meetings of the entire DVHRC membership: Will be scheduled as needed; subject to change as the DVHRC grows in membership.



- 6. <u>Disbursement of Funds</u>: Disbursement of funds will be to only those authorized by the DVHRC Executive Board. DVHRC will be a nonprofit organization and may only disburse funds in a manner that is in keeping with all local, state and national laws governing nonprofit organizations.
- 7. <u>Expulsion</u>: Any act of dishonesty will be grounds for immediate revocation of membership. Any member may be expelled or suspended from the DVHRC when the matter is brought before the general membership.
- 8. <u>Governing Rules</u>: The Executive Board may elect to adopt a set of "standing rules" to govern its membership, or amend these Bylaws. These standing rules or bylaw amendments shall be no less stringent, nor can they be in any conflict with the U.S. Constitution and the bylaws of the DVHRC.
- 9. Order: All meetings will be conducted under "Roberts Rules of Order."
