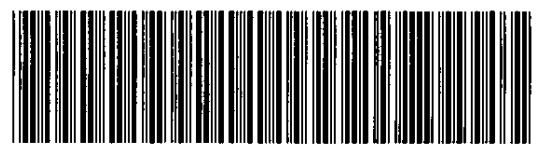

ARTICLE I – CORPORATE NAME

Booker T Washington Class Of 1967, Inc.

ARTICLE II – CORPORATE NATURE

This is a nonprofit corporation, organized solely for general charitable purposes pursuant to the Florida Corporations Not for Florida Law set in Part I of Chapter 617 of the Florida Statutes.

ARTICLE III – GENERAL AND SPECIFIC PURPOSE

Section One. **Booker T. Washington Class Of 1967** Is organized and shall be operated exclusively for charitable, educational, community development and other related purposes, including, but not limited to, sponsoring, organizing, administering, enhancing and operating activities for the benefit of the City of Pensacola, Florida and surrounding communities.

Section Two. **Booker T. Washington Class Of 1967** Is a not-for-profit corporation organized under Chapter 617, Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its directors or officers, except to the extent permissible under the Articles of Incorporation and Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code. No private individual shall have any vested right, interest or privilege in or to the assets, income, or property of the Corporation and no part of the income or assets of the Corporation shall be distributable to or for the benefit of private individual, except to the extent permissible under the Articles of Incorporation, Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code.

ARTICLE IV - COMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date of subscription and acknowledgement of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE V - BOARD OF DIRECTORS

All corporate powers shall be exercised by and under the authority of, and business and affairs of the corporation shall be managed under the direction of board of directors.

The corporation shall have seven (7) directors initially. The number of directors may thereafter be increased or decreased from time to time in accordance with the bylaws of the corporation.

ARTICLE X – DISTRIBUTION OF ASSETS

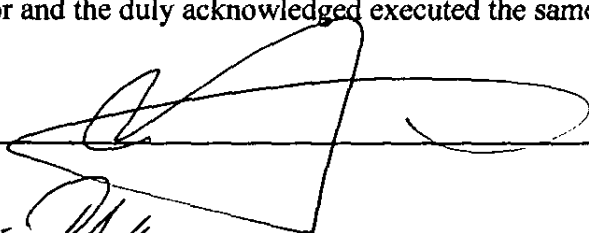

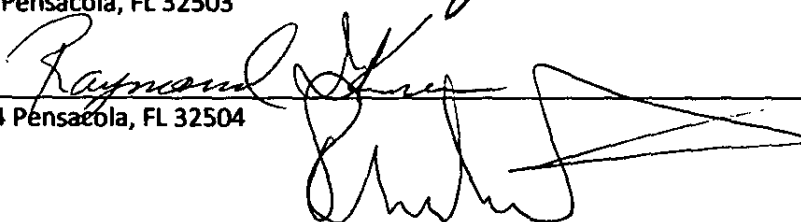
