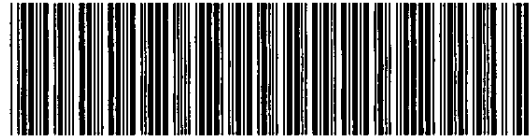



AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF

ARTICLE ONE. NAME

The name of the corporation shall be PRESCRIPTION ADDICTION REALLY KILLS FOUNDATION, INC.

ARTICLE TWO. PRINCIPAL OFFICE

The street address of the principal office of the corporation is 7489 Palmer Glen Circle, Sarasota, Florida 34240.

ARTICLE THREE. PURPOSE

The purpose for which the Corporation is organized shall be to educate and motivate the public to address the prescription addiction problem facing our country and to do all things necessary and proper within the scope of the Internal Revenue Code applicable to not for profit charitable organizations which further its purpose. The corporation is organized exclusively for charitable, educational, religious and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the maning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE FOUR. DIRECTORS

The manner in which directors are elected or appointed shall be as provided for in the bylaws of the corporation.

ARTICLE FIVE. REGISTERED OFFICE AND AGENT



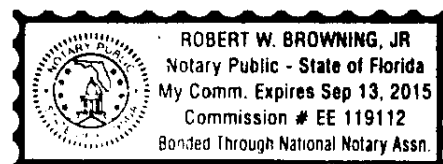


