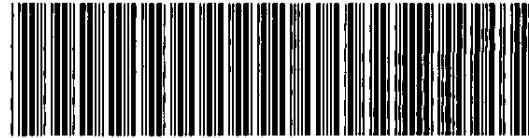





ARTICLE I
CORPORATE NAME

The name of the corporation shall be:

ARTICLE III
PURPOSE

The purpose for which the corporation is organized is:

Provide charitable contributions and to be exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code

ARTICLE IV
MANNER OF ELECTION

The manner in which the directors are elected and appointed:

The Board of Directors shall appoint the nominating committee of seven (plus two alternates) at the December Board Meeting. The purpose of this committee shall be to select a slate of officers for the following year.

The nominating committee shall be presented at the January meeting.

The slate of officers shall be presented in writing to the members by the nominating committee at least one week before elections via newsletter.

The annual election of officers shall be at the regular March meeting.

Further nominations may be made from the floor, provided that consent of the nominee has been obtained. Elections shall be held by secret ballot if there is more than one nominee for the same position.

Officers shall be installed in May and take office on June 15th. They shall serve for one year and may be re-elected for a second year. No one shall hold the same office for more than two consecutive years.

No member shall hold an elected position and chair a standing committee at the same time.

FEDERAL COMPLIANCE PROVISION**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation

**ARTICLE IX
DISSOLUTION OF ASSETS**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


