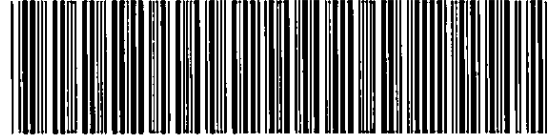

CHARTER OF FLORAL PARK PROPERTY OWNERS' ASSOCIATION  
A Non-Profit Corporation.

1. The name of this corporation shall be "FLORAL PARK PROPERTY OWNERS' ASSOCIATION". It shall be located in Floral Park, a Subdivision in the South half (S $\frac{1}{2}$ ) of Section 5, Township 45 south, Range 43 East, in Palm Beach County, Florida, lying west of Lake Osborne.
2. The general nature of the object of the corporation shall be to maintain an organization of the property owners in Floral Park in Palm Beach County, Florida to improve all roads and other thoroughfares; to maintain all parks therein for the benefit of property owners of Floral Park only; to enforce deed restrictions and zoning restrictions, either now in effect or which may be hereafter put in effect; to erect and maintain a community building wherein community meetings and other community enterprises may be held, and in general to promote all of the community, educational and charitable objects as are usually fostered, incurred and promoted by a community property owners association. To acquire by purchase, lease, rental or gift all real and personal property which can be used in the furtherance of its corporate purposes; to borrow money up to the legal limit of its borrowing power; to solicit and receive gifts of money, real property, personal property and mixed property; to buy, sell and mortgage its property and to do all and everything necessary, suitable and proper for the accomplishment of any of the purposes, the attainment of any of the objects, and the furtherance of any of the powers hereinbefore set forth, and to do every other act or acts, thing or things, incidental or appurtenant to, or growing out of or connected with the aforesaid objects, purposes or powers, or any of them.
3. All persons owning real property in Floral Park shall be eligible to membership in this corporation and shall be admitted

to membership upon payment of \$1.00 per member, and shall remain a member of this corporation as long as the annual dues are paid by such member.

4. This corporation shall have perpetual existence.

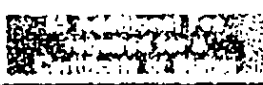

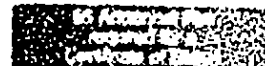

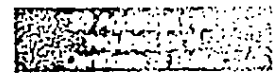
