Pursuant to the provisions of Section 617.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is **METRO-DADE AUTO TAG ASSOCIATION**, **INC.** (the "Corporation").
- 2. The Corporation was Filed on October 16, 1985, bearing Document Number N11621.
- 3. Article I of the Corporation's Articles of Incorporation is deleted and replaced by new Article I, as follows:

ARTICLE I NAME

The name of this Corporation is: MIAMI-DADE AUTO TAG ASSOCIATION, INC., a Florida corporation, and its principal office shall be located in Miami-Dade County, Florida.

4. These Articles of Amendment were adopted at a meeting held on the 12th day of July, 2001, attended and unanimously approved by a majority of the Corporation's Directors. There are no members or members entitled to vote on the amendment. The amendment was adopted by the board of directors.
