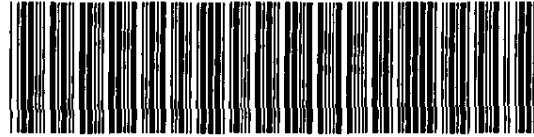

ARTICLE III

PURPOSE

*The purpose for which the corporation is organized is non-profit, a public benefit corporation. The Club (Club) is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to such organizations that qualify as exempt organizations under Section 501(c)3 of the Internal Revenue Code, or the corresponding section of any present and future federal tax code. The Club operates under the current Club bylaws with the option to add, amend, or delete.*

*MISSION: To honor the Rotary ideal of "Service Above Self." The Rotary Club of the Villages-Noon strengthens both local and worldwide communities by supporting programs that fight hunger, reduce child mortality, promote peace and conflict resolution, basic education and literacy, and the eradication of polio; and to uphold the principles, responsibilities, and obligations to and of Rotary International. Insofar as the provisions of the law of the State of Florida, under which this corporation is incorporated, shall permit, this corporation shall be subject to the jurisdiction of Rotary International.*

ARTICLE IV

MANNER OF ELECTION AND APPOINTMENT

*The Club shall have members, as provided in the Club's Bylaws. The management of the affairs of the Club shall be vested in a Board of Directors as defined in the Club's bylaws. No Director or member shall have any right, title, or interest in or to any property of the Club. The officers, elected by the Club, shall be president, president-elect, immediate past president, secretary, treasurer and five directors as provided in the Club's Bylaws.*
