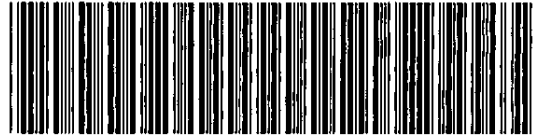

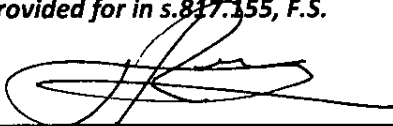
Article VIII – DATE

Article IX – DISSOLUTION OF THIS ORGANIZATION
