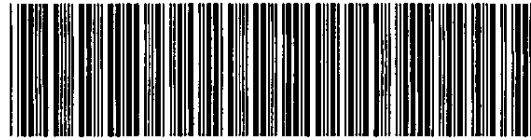

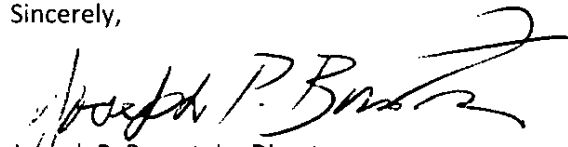

In accordance with the Bylaws of the Corporation and a Special meeting held on the 24th day of April, 2018, it was unanimously approved by the Board of Directors to:

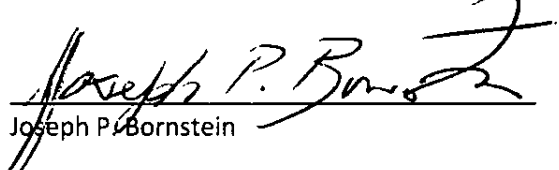
1. Change the name of Yummy Stuff Club, Inc. to CHILDREN'S HEALTHY PANTRY, INC. and

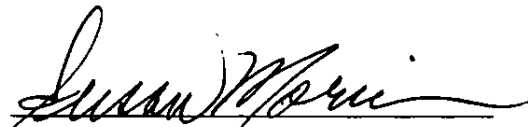
