ARTICLE III

SPECIFIC PURPOSE:

THE FLORIDA TARPONS IS A DRAGONBOAT TEAM ORGANIZED EXCLUSIVELY TO FOSTER STATE, NATIONAL, AND INTERNATIONAL COMPETITION EXCLUSIVELY FOR AMATEUR SPORT COMPETITION UNDER SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. UPON THE DISSOLUTION OF THIS ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.

ARTICLE IX

DESCRIPTION OF ACTIVITIES:

THE FLORIDA TARPONS DRAGONBOAT TEAM IS COMPRISED OF AMATEUR PADDLERS THAT TRAIN, PRACTICE AND RACE TOGETHER. RACES ARE ORGANIZED IN MANY CITIES AROUND THE STATE AND COUNTRY. TYPICALLY, THE TARPONS WILL ENTER EVENTS THAT COMPLY WITH THE RULES AND REGULATIONS OF THE INTERNATIONAL DRAGON BOAT FEDERATION (IDBF). PADDLERS IN THE PAST, PRESENT AND FUTURE PAY AN ANNUAL FEE FOR MEMBERSHIP, IN ADDITION TO PAYING FOR THEIR OWN RACING AND TRAVELING EXPENSES. PADDLERS COMMIT MANY HOURS A WEEK OF THEIR PERSONAL TIME TO THE SPORT OF PADDLING. THE FLORIDA TARPONS DRAGONBOAT TEAM'S MISSION IS TO BE A TEAM OF COMPETITIVE PADDLERS THAT COMPETE AT A VERY HIGH LEVEL. PREVIOUSLY KNOWN AS THE TAMPA TARPONS, THE TEAM'S NAME HAS BEEN CHANGE TO THE FLORIDA TARPONS AND FOR SIMPLICITY, COMMONLY CALLED THE TARPONS.
