ARTICLES OF INCORPORATION

OF

BETTY BLOETH MEMORIAL SCHOLARSHIP FUND, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation not for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: **Betty Bloeth Memorial Scholarship Fund, Inc.**

ARTICLE II. TERM OF EXISTENCE

The corporation shall have a perpetual existence, beginning upon the filing of these articles. If for any reason the corporation shall be dissolved or finally liquidated, all assets shall be transferred to St. Joseph's Endowment Fund, or, if it should cease to exist, another 501(c)(3) entity whose purpose is to confer college scholarships on deserving students.

ARTICLE III. INTIAL PRINCIPAL OFFICE

The Board of Directors may from time to time move the principal office to any other address.

ARTICLE IV. INTIAL REGISTERED OFFICE AND AGENT

ARTICLE V. DIRECTORS

ARTICLE VI. RESTRICTIONS

This corporation is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501(c) (3) of the Internal Revenue Code. The purpose of this corporation shall be to provide college scholarships for outstanding eighth grade students of St. Joseph's Catholic School in Winter Haven, Florida. Notwithstanding any other provision of these articles:

A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by an corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

B. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.






