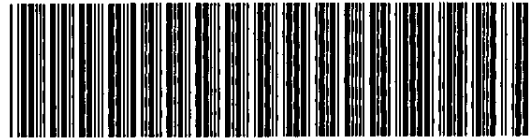

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name: The name of the corporation shall be: A Different Type of Courage, Inc.

Article III Purpose: The purpose for which the corporation is organized is:

ADTOC is organized exclusively for charitable and educational purposes including for such purposes, the making of distributions and organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Service Code, or the corresponding section of any future federal tax code.

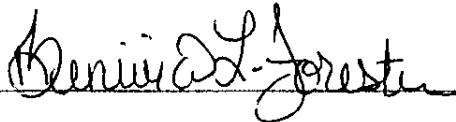

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office.

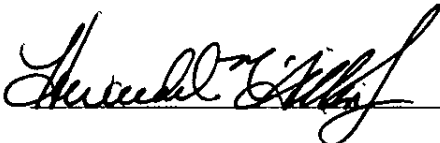
