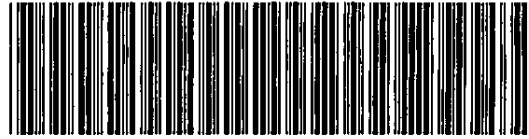

ARTICLES OF INCORPORATION  
FOR  
FREE INSIDE OUTREACH, INC.  
In compliance with Chapter 617, F.S., (Not for Profit)

We, the undersigned natural persons of the age of eighteen (18) years or more, at least two of whom are residents of the State of Florida, acting as Incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation.

I.

The name of the corporation is FREE INSIDE OUTREACH, INC.

II.

The place in this state where the principal office of the corporation is to be is 112 Loblolly Lane in the City of Midway, County of Gadsden. The mailing address is the same. The corporation may have such other offices, as may from time to time be designated by its Board of Directors. The period of duration of existence is perpetual and shall commence with the filing with the Secretary of State or on January 1, 2013, whichever comes later.

III.

Said corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the conducting of religious worship, publishing of literature, and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

To further the above purpose, the corporation shall have the full power to purchase, lease or otherwise acquire property, to publish religious materials, to own and/or operate radio or television stations, conduct worship services, support missionaries, raise funds, and to do those things necessary to promulgate the Gospel of Jesus Christ in an effective and efficient manner.

IV.

Board Directors and members will be elected or appointed in compliance with the corporate bylaws.

V.

The number of directors constituting the initial Board of Directors of the corporation is six (6). The names and addresses of the persons who are to serve as the initial directors are:

VIII.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in

article three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


IX.

X.



Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as Registered Agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as Registered Agent and agree to act in this capacity.


