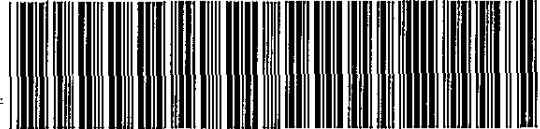

CORNERSTONE COMMUNITY CHURCH OF TAMPA, INC.**

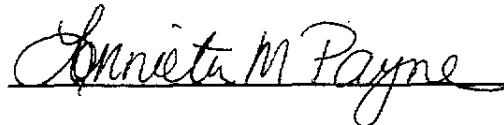
**KNOW ALL MEN BY THESE PRESENTS, That at a special meeting of the Board of Directors,

ARTICLE I.

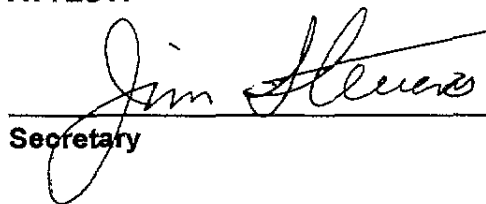
