

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WATERVIEW HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of §617.1006, Fla. Stat., WATERVIEW HOMEOWNERS ASSOCIATION, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted:

Article IV of the ARTICLES OF INCORPORATION OF WATERVIEW HOMEOWNERS ASSOCIATION, INC. ("Articles of Incorporation") is hereby amended as indicated in the attached Exhibit "A".

SECOND: The date of adoption of the Amendment was the 15th day of March,

<u>1990</u>.

THIRD: Adoption of Amendment:

Article XIII of the Articles of Incorporation, in effect prior to the adoption of the instant Amendment, provides that amendments to the Articles of Incorporation may be approved by the assent of two-thirds of the votes of each class of members.

The members of the corporation were entitled to vote on the Amendment. The members of the Association duly adopted this Amendment in accordance with the above-stated provision. The number of votes cast for the Amendment was sufficient for approval.

ARTICLES OF AMENDMENT OF WATERVIEW HOMEOWNERS ASSOCIATION, INC.

The undersigned officer of WATERVIEW HOMEOWNERS ASSOCIATION, INC., a corporation for profit under the laws of the State of Florida, does hereby amend the Articles of Incorporation of WATERVIEW HOMEOWHERS ASSOCIATION, INC.

Article IV is deleted in its entirety and substituted therefor is the following:

ARTICLE IV

The affairs of the Association shall be managed by a Board of Directors who need not be Members of Association. The number of directors may be changed by amendment of the Bylaws of the Association, but shall never be less than three (3) directors or more than nine (9). The number of directors shall always be an odd number.

The directors may, by Bylaw, fix the term of office for all directors. However, unless contrary provisions are made by Bylaw, each director's term of office shall be for one (1) There shall be held at each annual meeting of the Association an election of directors. Directors may serve successive annual terms without limitations.
