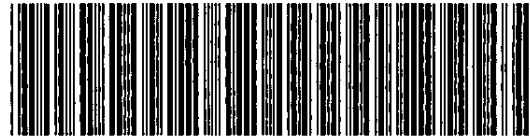

Nonprofit Corporation**

Article I

Article III

The purpose for which this organization is organized are providing religious, charitable, literary and educational services for **(1) Low and moderately income individuals, (2) For homeless individuals and families with children and (3) Handicapped person.**

To provide or obtain the support services necessary to ensure the people involved succeed in becoming productive tax paying citizens. This includes but not limited to: Job training and/or placement, vocational training or continuing education, counseling (Family, religious, substance abuse, etc.) legal advice, budgeting and nutritional training.

The foregoing purpose and activities are examples only and not limitations nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful purpose which may become necessary or desirable for the furtherance of the corporation objectives set forth above.

Generally, to carry out any act that is not in consistent with the corporation laws of the State Of Florida or any other laws, and any act which the Board of Directors may determine from time to time

to do that which is in accord with the non-profit purpose of this corporation.

To engage in lawful activities in support of the above purpose, not for pecuniary gain as prohibited by Florida Law, and to have, and exercise all the rights and power conferred on non-profit corporations under Florida Law as such law is now in effect or may at anytime hereafter be amended.

Notwithstanding any other provisions of these articles, this Corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501© (3) of The Internal Revenue Code of 1954 or the corresponding provision of any further United States Internal Revenue Law.

Article IV

The qualifications for members and the manner of their admission shall be regulated by the by Laws.

Articles V
