

ARTICLES OF INCORPORATION of GIVE A LITTLE HOPE, INC.

The undersigned incorporator hereby forms a non-profit corporation under the Florida Not For Profit Corporation Act.

Article I - NAME

The name of the corporation shall be: GIVE A LITTLE HOPE, INC.

Article II - PRINCIPAL OFFICE

The principal office address of the Corporation shall be: 1941 Academy Street NE, Palm Bay, FL 32905; and the mailing address of the Corporation shall be: 1941 Academy Street NE, Palm Bay, FL 32905.

Article III - PURPOSE

The purpose for which the corporation is organized is to establish a Christian ministry and further the Gospel of Jesus Christ.

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code,

or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV - NON-STOCK CORPORATION

The corporation shall have no stock and no dividends shall be declared or paid.

Article V - DIRECTORS

The business and affairs of the corporation shall be managed by a Board of Directors. The Board of Directors shall be comprised of not less than three (3) individuals. The method of election, appointment, term of office, removal and filling of vacancies of the Board of Directors shall be as set forth in the Bylaws of the corporation. The names and addresses of the persons who are currently serving as Directors of the corporation are as follows:

Article VI - OFFICERS

The corporation shall have the following Officers: President, Vice President, Secretary and Treasurer. An individual may hold more than one office. The corporation shall reserve the right to have such additional Officers as necessary for governing or for the conduction of its affairs, as may be provided for by the Bylaws of the corporation. The method of election, appointment, term of office, removal and filling of vacancies of all Officers shall be as set forth in the Bylaws of the corporation.

Article VII - REGISTERED AGENT

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
