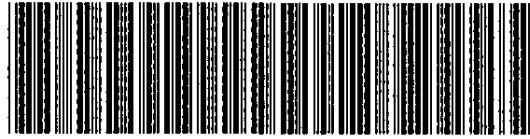

# Article III: Purpose

page 1 of 2

The purpose for which the corporation is organized is: to establish and maintain nondenominational community Churches as places of worship for those that desire the right hand of fellowship, to build and maintain a unified body of persons who believe in the teachings of our Lord Jesus Christ, to establish learning facilities, and feed the hungry, assist the homeless, and set up help groups with the same nonprofit purpose; to ordain and license ministers upon completion of a prescribed course; to grant a charter to, and to assist in the establishment of other churches; and to send forth missionaries for the establishment of other churches, both domestic and foreign. The Corporation shall be able to acquire, own and operate broadcasting and or telecasting facilities; and to accept donations for religious or charitable purposes.

The Corporation is formed for lawful nonprofit purposes and objectives. No stock or securities will be issued. All Corporate assets will be dedicated to exempt purposes; although the Corporation will be authorized to pay reasonable compensation for services rendered, and to enter into business transactions in furtherance of its exempt purposes.

The Corporation will not pay dividends.

and its assets will not inure to the private profit of any person.

Upon dissolution of the Corporation, the Board of Trustees shall, after paying or making provisions for the payment of all the liabilities of the Corporation, dispose of all the assets of the Corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any such assets as not so disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
