

Non-Profit Articles of Incorporation

Of

Bully Armor, Inc.

ARTICLE I

Name and Duration

The name of the corporations is Bully Armor, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Article are filed by the Secretary of State.

ARTICLE II

Principal Office

The address of the Corporation is 689 Deltona Blvd., Deltona, FL 32725.

ARTICLE III

Registered Office and Agent

The address of the registered office of the Corporation in the State of Florida in 689 Deltona Blvd., Deltona, FL. 32725. The name of the registered agent at such address is Nichols Pizza.

ARTICLE IV

Corporate Purposes, Powers and Right

- The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in a not for profit bullying education program for school age children.
- 2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a Corporation by the Florida Business Corporation Act.
- 3. Said Corporation id organized for educational purposes.
- 4. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, directors officers or pother private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(C)(3). No substantial part of the activities of the Corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in including the publishing or distribution of statement) any political campaign on behalf of, or in opposition to, any candidate for public office.

- 5. Notwithstanding any other provision of the Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt purposes within the meaning of Section501(C)(3) of the Internal Revenue Code or (B) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code, or shall be distributed to the Federal Government, or to a state or local Government, for a public purpose.
- 6. Upon dissolution of the Corporation assets shall be distributed for one or more exempt purposes within the meaning of Statute 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

ARTICLE V

Board of Directors

A Board of Directors of no less than 3 persons shall be initially appointed and other board members shall be appointed an thereafter elected.
