Section E Continuation Sheets to Standard Form Amending Florida Not-for-Profit Articles of Incorporation

1. Delete Article III in its entirety and replace it with the following revised Article III.

Article III

The specific purpose for which this corporation is organized is as follows.

The organization is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Judy's Cupboard is organized to assist schools in Palm Beach County, Florida, but specifically in the City of Riviera Beach, Florida, whose majority of students are entitled to free and/or reduced lunch, in providing various types of school supplies to children for their educational needs. Each cupboard would contain necessary school supplies for children who are unable to afford them. Teachers, counselors, and school administrators would be able to hand out supplies directly to the children without delay.

2. Add a new Article VIII which reads as follows.

Article VIII

Dissolution of the Foundation - Upon the dissolution of this organization, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose(s).

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized exclusively for such purposes.

3. Add a new Article IX which reads as follows.

Article IX

Prohibited Activities - No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.

No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
