In that there is no intention to revoke the voluntary dissolution, we request the name be released for the filing of the Not For Profit entity.

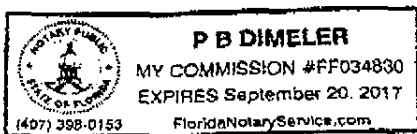
