- 1. The following provisions of the Articles of Incorporation of Mandarin Oaks Reserve

  November 1, 2013, be and they hereby are amended in the following particulars:
  - A. Article VII Section 2 hereby is amended to read as follows:

Upon conversion of the Class B membership to Class A membership at turnover of the Association, the former Class B Members shall have one vote per Lot owned. In addition, until such a time as the class B membership is converted to Class A membership, the Class B membership shall have a right of veto on all questions coming before the membership for a vote.
- 2. The foregoing amendment was adopted by the Board of Directors of the Corporation on the 18th day of November, 2014. There are no members entitled to vote on the amendment.


