The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**Article I**

The name of the Corporation shall be Holy Redeemer Church, Inc.

**Article II**

The place in this state where the principal office of the Corporation is to be located is: 2443 N.W. 179<sup>th</sup> Street, Miami Gardens, Florida, Dade County

**Article III**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article IV**

There shall be four members of the initial Board of Directors of the Corporation. The method of election of directors is as stated in the bylaws.




Article VIII

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The By-Laws of the corporation shall be adopted by the Board of Directors of the Holy Redeemer Church, Inc., and may be amended and changed from time to time by the Board of Directors.


