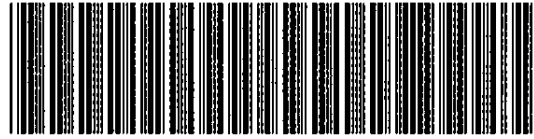

ARTICLE I: NAME

The name of the corporation shall be “VIETNAMESE BUDDHIST CENTER OF FLORIDA, INC. – KHANH VIET TEMPLE.”

ARTICLE II: PRINCIPAL OFFICE

The principal office and mailing address of the corporation shall be 4341 SW 54th Avenue, Davie, Florida 33314-3828.

ARTICLE III: PURPOSE

The purpose of the corporation is to engage in the following business activities:

1. To establish, maintain and exhibiting Buddhist religious, cultural, educational traditional spiritual activities based on the Buddha Dharma (Buddhism) in order to preserve the Buddhist values and to educate both old and new generations on weekly basis and as much as needed to strengthen the 2600 years of history of Buddha’s doctrinal teachings in its original and traditional form and contribution of moral knowledge and wisdom to the public those whose are solely interested.

2. This corporation is a Religious Corporation and is not organized for the private gain of any person. It is organized under the Non-Profit Religious Corporation Law exclusively for religious purposes.

3. This corporation is organized and operated exclusively for religious purposes within the meaning of Internal Revenue Code section 501(c)(3).

4. The corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 and a corporation to which the contributions are tax exempt under Section 170(c)(2) of the Internal Revenue Code 1954 or the corresponding provision of any future United States Internal Revenue Law.

5. No substantial of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not

participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

6. The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

7. No officer or director of this corporation shall be personally liable for the debts or obligation of this corporation of any nature whatsoever, nor shall any of the property of the officers or directors be subject to the payment of the debts or obligations of this corporation.

8. Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).




