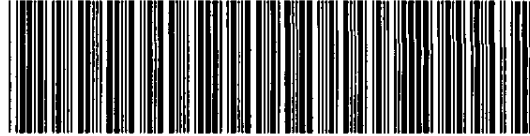

Article III -Amended as follow:

The Corporation is organized and shall be operated exclusively for religious purposes within the the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended (or corresponding section of any future federal tax code.)

The church shall not carry on any activities not permitted to be carried on (a)by corporations exempt from federal income tax under Section 501(c)(3) of the Code or (b) By a corporation contributions to which are deductible under Section 170(c)(2) of the Code. This church has not been formed for pecuniary profit or gain. No part of the assets, income, or profits of the church shall insure to the benefit of its members, council members, trustees, or officers or to any individual. However, the church shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article III. No substantial part of the activities of this church shall consist of carrying on propaganda, or otherwise attempting to influence legislation. This church shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Add: Article IX

Article IX Dissolution

Upon the dissolution of the corporation, none of its funds or assets shall be distributed to any officer, trustee, or any other individual.

The church board shall, after paying or making provision for the payment of all of the liabilities of the church, dispose of all of the funds and assets of the church by conveying the same to any organization at the time that qualifies as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law). Any such funds or assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, to such organization as said Court shall determine, which is organized and operated exclusively for religious purposes.

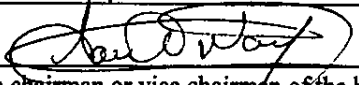
