These Articles of Amendment to Articles of Incorporation of The Pointe at Twenty Mile Homeowners Association, Inc., are made effective as of October 20, 2014 (the "Effective Date"), by **THE POINTE AT TWENTY MILE HOMEOWNERS ASSOCIATION, INC.**, a Florida not-for-profit corporation (the "Association") to change the Association's name from The Pointe at Twenty Mile Homeowners Association, Inc. to **TWENTY MILE WEST HOMEOWNERS ASSOCIATION, INC.**

RECITALS:


A. The Association desires to amend its Articles of Incorporation (the "Articles") as more particularly described hereafter and these Articles of Amendment have been proposed by the Association's Board of Directors and were approved on the Effective Date by the affirmative vote of Members holding not less than a majority of the total votes allocated to the Members of the Association.

NOW THEREFORE, the Association hereby amends the Articles as follows:

1. All references in the Articles to "The Pointe at Twenty Mile Homeowners Association, Inc." are changed to "Twenty Mile West Homeowners Association, Inc."
2. All references in the Articles to "The Pointe at Twenty Mile" are changed to "Twenty Mile West".
3. Except as specifically amended hereby, the Articles otherwise shall remain in full force and effect.
