

Article III-The specific purposes for which this corporation organized:

Hand in Hand Lake County Inc will create a program that will facilitate the rebuilding of lives and families by reaching out to the poor, disconnected, sick, and lost. Hand in Hand will organize, publicize, and execute servant events in the Golden Triangle area of Lake County. Partnering with like-minded humanitarian organizations, Hand in Hand will offer people in the community the opportunity to serve those in need. Said corporation is organized exclusively for charitable purposes, including, for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Article IX: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, Trustees, officers or other private persons, except that the corporation shall be authorized to pay reasonable Compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not withstanding any other provision of these articles, the corporation shall not carry on any other activities not Permitted to be carried on (a) by a corporation exempt from federal income tax under section 502 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation to which are deductible under section 170(c)(2) of the internal Revenue Code, or the corresponding section of any future tax code. Article X: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within The meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization(s) as said Court shall determine, which are organized and operate exclusively for such purposes.
