**Articles of Incorporation of**  
**Single Moms United Foundation Inc.**

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows:

Single Moms United main purpose is to help single moms and their families in difficult circumstances or crisis. We offer support groups, orientation, counseling, guidance, provisional shelter in case of emergency, education, employment searching tools and resources to connect them with government assistance programs. Also, our goal is to help them reach auto-sufficiency, by giving tools to do so.

Additional services include:

- Home Ownership Program
- Application & Interview Process)
- Orientation in Scholarship Funds availability.
- Career training and placement assistance. Resume Building and
- Education: English classes, computer literacy courses, arts & crafts, yoga, tools in how to cope with stress, financial advice and organization, etc.,
- Monthly Conferences in parenting.
- Food Bank where we provide emergency food.
- Diaper Bank. (diapers, bottles, formula and baby wipes)
- Our Thrift store will provide Free quality clothe for the family, in return we ask for voluntarism and program participation.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
